ADDITIONAL REQUIREMENTS

- ∞ All organizations must provide proof of insurance.
- ∞ \$250.00 damage deposit required for Categories II, III and IV, unless otherwise specified in a formal agreement.
- ∞ All Category II organizations must provide proof of non-profit status.
- ∞ All fees are due in advance.
- ∞ A \$15.00 application processing fee for all Category II and IV requests will be due upon submittal.
- ∞ All fees to be figured to the nearest ½ hour. Failure to provide a minimum forty-eight (48) business hours notice of cancellation will result in a \$25.00 cancellation fee.
